Tenure	Perpetual
Purpose of Corporation	The purpose of this organization shall be to promote interest and active participation in amateur radio, emergency communication and public service; and provide a funding mechanism for the Amateur Radio Relay League (ARRL) Western Washington (WWa) Amateur Radio Emergency Service. (ARES) All of the purposes and powers of the Corporation shall be exercised exclusively for the charitable, scientific and educational purposes in such manner that the Corporation shall qualify as an exempt organization under Section 501 (c) (3) of the Internal Revenue Code of 1986, as amended (the "Code") or any successor provision, and that contributions to the Corporation shall be deductible under Section 170 (c) (2) of the Code or any successor provision.
Effective Date of Incorporation	Date of Filing
Distribution of Assets	Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
